## St. Eugene School Bus Boundaries 2023-24

Northern boundary: Milwaukee/Ozaukee County Line from Range Line Road on the west to Lake Michigan on the east

Eastern boundary: Lake Michigan from the Milwaukee/Ozaukee County Line on the north to the extension of Daphne Road on the south

Southern boundary: Daphne Road and its extension from Lake Michigan on the east to Green Bay Road, south on Green Bay Road to Silver Spring Drive, west on Silver Spring Drive to 27<sup>th</sup> Street/Range Line Road.

Western boundary: 27<sup>th</sup> Street/Range Line Road from Silver Spring Drive to Green Bay Road, north on Green Bay Road to Dean Road, east on Dean Road to Range Line Road, then north on Range Line Road to the Milwaukee/Ozaukee County Line
